Farewell to Margaret Callsen

Many of us were saddened by the unexpected death of long-time AAUW member Margaret Callsen at the beginning of April. She was active in the Fargo/Moorhead Retired Home Economists and in Red River Danes. She volunteered with the "Giving + Learning" program for a number of years and served as a Court Watch for the Rape and Abuse Crisis Center. She served on the governing board of the Broadmoor Condominiums. As a weekly volunteer for the Historical and Cultural Society of Clay County for the last 20 years, Margaret was a fixture in the museum. When one of her fellow volunteers, Dorothy Heieie, was unable to reach her for over a week, she went to Margaret's residence and found she had passed away. Boulger Funeral Home was unable to locate any close relatives, Margaret having been an only child. However, many of her friends and acquaintances gathered at Boulger's for a very nice memorial service. Her Concordia College classmate, the Rev. Lyle Rich, provided a brief spiritual message among a variety of songs. It turns out that Margaret had arranged to leave a legacy to Concordia College to fund a program of student-scholars working with new faculty on research projects. The people who gathered came from many different walks of life and shared stories about Margaret's quiet sense of humor, which she had shared at AAUW meetings for many years.

Report on the ND Annual Meeting of the Membership

The executive committee is to be commended for preparing a wonderful state annual meeting April 25 and 26. Friday night they hosted a delicious dinner at the Plains Art Museum. Lorna Williams provided the enchanting piano music during dinner. Attendees the viewed a video message from Senator Heidi Heitkamp before hearing live remarks by two dynamic ND legislators Kathy Hogan of Fargo (District 21) and Jessica Haak of Jamestown. A tasty dinner was prepared by Mosaic Catering, and the setting among the art was especially appealing. Attended by 85 people, about half AAUW members, the evening was a huge success.

Saturday morning the convention continued at Howard Johnson Inn with almost 50 participants. From the national office, Anne Hedgepeth, gave a lively presentation on the public policy issues AAUW continues to work on in Washington. It is exciting to hear about the impact that AAUW is having on the lives of all Americans. Then new Fargo member Molly McLain shared her concerns about the Voter ID requirement and how it will disenfranchise many voters. After Molly, AAUW New Jersey president and national board member Sally Goodson shared a thorough review of all of AAUW programs with lively video clips.

During lunch AAUW ND president Maureen Kelly Jonason shared the results of the election: Debbie Alber of Jamestown will be the new state president and our own Bobbe Shreve will be the state secretary. All of the changes to the bylaws were accepted and the increase in state dues was passed. Lunch speaker and student affiliate Sarah Klindworth shared her experience at the National Conf. for College Women Student Leaders (abbreviated as NCCWSL and pronounced nick-whistle) in College Park , Maryland, last year. After lunch, North Dakota Women's Network director Renee Stromme shared the research on women's leadership in the state and the opposition to the proposed amendment to the ND Constitution referred to as the personhood bill, Measure 1. Molly McLain is also working actively to raise awareness of and funds for the fight against this measure which will not only ban all abortion in every case but could have the unintended consequences of criminalizing in vitro fertilization and possibly causing investigations of miscarriages as well as removing the right to make one's end-of-life decisions. Even some anti-choice proponents have rejected Measure 1 because of the unintended consequences.

At 2:30 the educational component completed, the annual meeting began. Much of the meeting was used to discuss future plans for AAUW in ND. President Maureen recommended

branches consider making AAUW the focus on at least some meetings in the coming year in order for everyone to stay abreast of current issues. President-elect Debbie Alber also asked for feedback on her idea to hold a summer board retreat and for discussion of trying for another Impact Grant from national to work on Pay Equity and Human Trafficking as well as Get Out The Vote work. The meeting concluded at 4pm. Overall, the weekend was a big success. Congratulations to President Joan Justesen, President-elect Laurie Wigtil, Secretary Bobbe Shreve, Treasurer Lucia Schroeder, Membership Chair Ruth Stefonowitz, Molly McLain and Dena Wyum for their year of planning and hard work.

ND First in Growth of Women-owned Firms

North Dakota ranks first for growth in number and economic clout of women-owned businesses in a new census-based report. The state has an estimated 20,700 women-owned firms that, combined, employ 21,300 workers and have \$3.2 million in sales.

The No. 1 ranking for combined economic clout was based on averaging rankings for growth in the number, revenues, and employment of women-owned firms from 1997 to 2014. Minnesota ranked 35th in combined economic clout.
