### **PRESIDENT'S COMMENTS**

You will be glad you attended the next Fargo-Moorhead AAUW Branch Meeting the second Monday of the month, October 13, 2014 beginning at 5:30 pm with the program start at 6:15 pm.

The program will be presented by Jeanne Hettich, Admissions Counselor at Minnesota State University Moorhead and recent graduate of the Counseling & Student Affairs Master's program. She focused on mental health counseling for college women and researched experience of new student orientation, on-campus programming, and volunteer experience with a local women's shelter.

Ms Hettich will present on "Campus Sexual Assault: Current Prevention Efforts." She came to our September meeting because she was concerned about the recent sexual assault case on MSUM campus. This is a timely and significant topic for us to explore. I hope you can make the meeting.

Sandy Sidler, our Public Policy Chair, requested information from our National AAUW office and this is their recommendation related to the Parental Rights Initiative, Measure # 6. ND-AAUW should oppose this ballot initiative. There are two reasons for this recommendation: First, in its past, AAUW has adopted member resolutions endorsing the UN Convention on the Rights of the Child and the UN Declaration of the Rights of the Child. Although these treaties note the importance of parents and call for children to be kept with parents whenever possible, both treaties also call for the "best interests of the child" to be the "primary" and "paramount" consideration. That's the standard established by these treaties as well as the proposed ND parents. AAUW members have endorsed keeping the "best interests" of the child as the top concern of the state. The ND ballot initiative goes against that by giving parents equal weight to the child's interest.

Additionally, the language of the ballot initiative doesn't clarify what makes someone not a "fit parent." It says that the fitness of a parent "shall only be rebutted upon a showing by clear and convincing evidence," but it doesn't really define that. AAUW members in other states have worked on legislation to protect rape survivors from having to share custody with their rapists or abusers. It's a matter of concern that this shared parenting law could allow open the door to this happening or even becoming routine.

Disadvantages are the upcoming construction on 2<sup>nd</sup> Street and the lack of flexibility in price and choice of meals. No decision was made at this time. Changing the meeting date to the second Monday of the month was approved by vote after discussion.

# National Conference Held for College Women Leaders


Held at the University of Maryland in College Park June 5 to 7, some thirty AAUW leaders were invited to attend, including Dr. Yvonnne Condell of the Fargo-Moorhead branch. AAUW leaders represented branches from across the United States as well as Puerto Rico to participate in the conference.

The keynote address was presented by Chelsea Clinton who spoke about the characteristics of effective leaders. At the session five "Women of Distinction" were honored. The 2014 Women of Distinction are as follows:

- Hattie Kauffman, television anchor and news correspondent (a University of Minnesota graduate);
- Lily Liu, cofounder, Public Stuff;
- Pamela Ann Melroy, former NASA astronaut;
- DiRionne P. Pollard, president of Montgomery College, Maryland; and
- Judy Smith, co-executive producer of Scandale and founder and president of Smith and Company

Nine hundred women student leaders representing colleges and universities across the United States were in attendance. AAUW branches in Minnesota and North Dakota sponsored several women leaders. The Minnesota brancheswere Brainerd, Ely, Grand Rapids, Rochester, and Willmar. The Jamestown branch sponsored a tudent. Workshops for the conference were presented daily from 10:15-11:30 a.m.; 1:345-3:00, 3:15-4:30, and 4:45-6:00 p.m. A total of sixty-four workshops were offered.

Conversations with AAUW leaders and students were informative and inspiring. Students range in age from tradition four-year students, older-than-average students to graduate and professional students. Students were studying at a variety of institutions, such as community colleges, undergraduate public and private colleges and universities, and graduate and professional schools.
